The Church shall have, by the signing of this document, the right to assign its rights in the Property, in whole or in part, to any entity, parish, or school within the Archdiocese of Baltimore.

I hereby irrevocably grant the Church the right to use (alone or together with other materials), in whole or in part, the Property, for use in any Church publication, news release, or for any other purpose. Further, I hereby authorize the reproduction, sale, lease, copyright, exhibition, broadcast and/or distribution of the Property without limitation for any lawful purpose whatsoever, and I further waive all rights to any compensation for my and/or my child's appearance or participation. I understand and have been advised that photographs or videotape of participants may be used in publications, websites or other materials produced from time to time by the Church, its Office of Youth and Young Adult Ministry and/or the Archdiocese of Baltimore. Participants' names would not be identified, however, without specific written consent. I further understand that the Church has no control over the use of photographs or film taken by others.

I hereby waive any claims against and release the Church, its current, former, and future religious, employees, volunteers, agents, and successors and assigns from and against any and all claims, demands, actions, causes of actions, suits, costs, expenses, liabilities, and damages whatsoever that I and/or my child may have against the Church in connection with the Property or the lawful use of the Property.
